

To: All Business Entities Licensed for Surplus Lines in Delaware

Subj.: ANNUAL AGENCY REPORT FORM SL-1706

All business entities licensed for surplus lines must submit this report. This is the only report required from business entities.

The Insurance Department introduced the BUSINESS ENTITY REPORT OF AFFILIATED INDIVIDUAL SURPLUS LINES BROKERS, Form SL-1706, referred to as the "Agency Annual", last year for the calendar year 2005 year-end filing. Business entities (agencies, brokerages, firms, etc.) use this form to list all surplus lines brokers active in the state of Delaware, resident and non-resident, who were affiliated with the business entity during the calendar year. The Agency Annual report is due on or before March 1 each year.

The *Surplus Lines Broker Premium Tax Annual Summary Report (Form SL-1916)* should **NOT** be submitted for a business entity. However, please remind each individual surplus lines broker affiliated with your agency that he or she **must** file the SL-1916 on or before March 1, 2008, whether or not he or she procured any business in Delaware during calendar year 2008.

Please note that the SL-1706 Agency Annual report is for Surplus Lines only. Affiliated brokers who hold a valid Delaware surplus lines license are considered active whether or not they procured any surplus lines business in Delaware during the calendar year, and should be listed on the report with zero premiums if applicable.

The Department will use the information from the SL-1706 Agency Annual report to match with information reported by individual surplus lines brokers and non-admitted insurers to monitor surplus lines insurance throughout the state.

To be used by insurance agencies to report information listing individual surplus lines brokers employed by or representing the agency and the aggregate volume of surplus lines business written on risks located in Delaware by each licensed SL broker during the calendar year in association with the agency.

THIS REPORT IS FOR SURPLUS LINES BUSINESS ONLY.

No policy detail information is required on this report, only the Delaware surplus lines premium volume for each SL broker and the agency total. List all SL brokers affiliated with the agency whether or not they procured any business. If no SL business was written, enter zero. This information will allow the Department to match insurance company reports to monitor surplus lines business throughout the state.

REMINDER: Each individual surplus lines broker is required to submit a separate Surplus Lines Broker Premium Tax Annual Summary Report (Form SL-1916-07)

This SL-1706-07 report must be completed and returned to the address at the right on or before March 1, 2008.
